The Ministry of Tribal Affairs (MoTA), Government of India, has established Eklavya Model Residential Schools (EMRS) across all states to provide quality education to tribal students, ensuring parity with non-tribal students. For the Academic Session 2025-26, there will be 05(five) EMRS operational in Assam under the administrative control of the Assam State Level Eklavya Model Residential Schools Society (ASLEMRSS) a registered society under the aegis of Social Welfare & Tribal Affairs Department, Government of Assam.

The admission to Class- VI of EMRSs will be done on merit through an Entrance Examination for the EMRS located at 1) **Kharadhara, Dist. Bajali, Assam** 2) **Jalah, Dist. Baksa, Assam**, 3) **Jonai, Dist. Dhemaji, Assam** 4) **Howraghat, Dist. Karbi Anglong, Assam** and 5) **Ardaopur, Dist. Dima Hasao, Assam**. The Examination Centres for the Entrance Examination shall also be located in the same districts.

The Application form shall be submitted in online mode only. Necessary link will be available in the official website **<https://avs.assam.gov.in>** shortly.

No hardcopy/ post copy shall be accepted.

**1.3 SELECTION PROCEDURE:**

- I. The Age Limit for admission to Class- VI shall be **minimum age is 10 Years as on 31/03/2025 and maximum age is 13 Years as on 31/03/2025. Child born on 1<sup>st</sup> April should also be considered.**
- II. The Family Annual Income of the **applicant shall not be more than 5 lakhs.**
- III. The candidates must be **Permanent Resident of Assam.**
- IV. Candidate should **have qualified Class V** from a Govt./ Govt. aided/ Govt. recognized School/ CBSE Affiliated School/ Level B of NIOS OBE Program Or a Candidate who has not attended any school but studied at home is also eligible to apply for admission in Class VI (As per section 4 of Chapter II of RTE Act, 2009). However, the parents/ guardian of the candidate shall have to submit a self-declaration regarding the same.

**1.4: RESERVATION POLICY:**

The reservation policy as mentioned in the Admission Guidelines for EMRS as available in the EMRSS website <https://nests.tribal.gov.in/WriteReadData/RTF1984/1735810484.pdf> shall be followed while preparing final selection list. Applicants or their parents/guardians must go through the same 'Admission Guidelines' in detail.
